Explanation of Responses:

- 25,000 shares of Common Stock represent a grant of performance-based restricted stock that shall vest one-third each year on the anniversary date of the issuance date if applicable performance conditions are achieved. Thus one-third may vest on each of July 20, 2011, July 20, 2012 and July 20, 2013.
